Question

Bob Benson is a farmer. He grows sweet corn for sale as animal feed; to facilitate growth of the corn (as well as to manufacture and sell honey), he keeps several hives of bees. During the growing season the bees venture beyond his property to that of his neighbor, Dan DeLuccia, who is also a corn grower. The bees pollinate DeLuccia's corn and return with the wherewithal to make honey.

In June of 1992 Dan noticed that some of his sweet corn fields were infested with corn borers and earworms. In order to control these pests, Dan contracted with Ag-Aire, Inc., to spray the pesticide Sevin on the affected fields. On June 13, 1992, Benson observed an Ag-Aire helicopter aerially spraying Dan's sweet corn field. After the spraying Bennett noticed that many of the bees in an observation hive at his home were dead or dying. Benson also observed severe damage to several other of his colonies in the vicinity of the sprayed field. His damages amount to \$50,000.

Benson has come to your office to find out if he can recover for his losses. In the course of your investigation you discover the following facts:

The Sevin label included the following warning:

"BEE CAUTION: MAY KILL HONEYBEES IN SUBSTANTIAL NUMBERS "This product is highly toxic to bees exposed to direct treatment or residues on crops

"Do not use when value of honeybees as pollinators is more important than insect control. Before applying, warn beekeepers to locate hives beyond bee flight range until one week after application or to take other equally effective precautions."

The Administrative Code of this state provides, § 29.10(1): "No person shall use ... pesticides contrary to label directions, or in a careless or reckless manner." The Code provides civil forfeitures for violations and criminal penalties for knowing violations of the statutes or regulations.

How would you advise Bob?
